

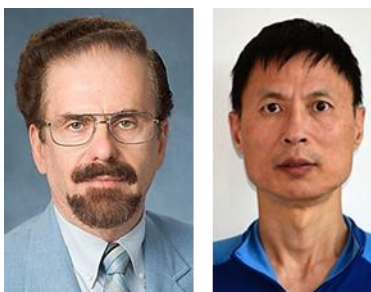

## KU's Barnett, Han Among Four to Receive Higuchi Research Awards



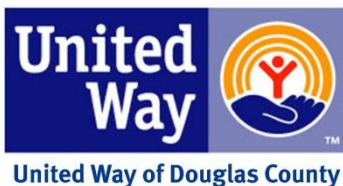
William Barnett, Oswald Distinguished Professor in the Department of Economics, and Siyuan Han, professor in the Department of Physics and Astronomy, have been named recipients of the state's most prestigious recognition for scholarly excellence: the **Higuchi-KU Endowment Research Achievement Awards**.

They will be honored on October 30 during a ceremony at the Lied Center, long with William Groutas, Distinguished Professor in the Department of Chemistry, Wichita State University, and Mary Beth Kirkham, professor in the Department of Agronomy, Kansas State University.

Barnett will receive the Balfour Jeffrey Award in Humanities and Social Sciences, while Han will receive the Olin Petefish Award in Basic Science. Groutas will receive the Dolph Simons Award in Biomedical Sciences, and Kirkham will receive the Irvin Youngberg Award for Applied Sciences.

This is the 32<sup>nd</sup> annual presentation of the awards, which recognize the exceptional long-term research accomplishments of faculty at Kansas Board of Regents universities. Each award includes a citation and a \$10,000 award for ongoing research efforts. The money can be used for research materials, summer salaries, fellowship matching funds, hiring research assistants or other support related to research.

Attendance at the presentation ceremony is by invitation. Chancellor Bernadette Gray-Little will speak, and will be joined by Jeff Vitter, provost and executive vice chancellor, and Steve Warren, vice chancellor for research and graduate studies. Past recipients will also be recognized.

## Five Strategic Initiative Grants (SIG) Announced from Latest Level I Reviews

The [Research Investment Council](#) was established last year to solicit, review and recommend action on Level I proposals to KU's Strategic Initiative Grant program. These involve requests of more than \$50,000, but typically in the \$100,000 to \$300,000 range. ## Speaker to Discuss Process for Obtaining SBIR Grants from NIH



Lisa Kurek, left, a nationally recognized trainer in grant writing and commercialization for entrepreneurs, will present a free workshop on Monday, October 21 on the topic of "Small Business Innovation Research (SBIR) Grants: How to be Successful at NIH." The presentation will take place from 8:30 a.m. to 4 p.m. at the Bioscience & Technology Business Center and is open to KU faculty, staff, students and the invited public. Space is limited.

The SBIR program reserves a portion of the extramural research budgets of certain federal agencies for contracts or grants to small businesses. The annual amount available exceeds \$1 billion, and more than half the awards are to firms with fewer than 25 people. The objectives of the program are to spur technological innovation in the small business sector, meet the research and development needs of the federal government, and commercialize federally funded investments.

Kurek is an expert on the SBIR application process. Since 1997, she has been managing partner of BBC Entrepreneurial Training & Consulting LLC in Ann Arbor. BBC works with universities, economic developers, and businesses to create and grow new life science companies.

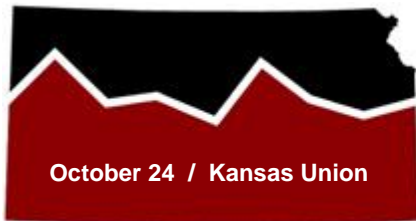

## Collaboration with BTBC a "Community-Connected Campus" Award Finalist

The nationwide University Economic Development Association (UEDA) has invited KU Innovation & Collaboration (KUIC) and the Bioscience & Technology Business Center (BTBC) to make a formal presentation in Pittsburgh during the UEDA Annual Summit October 27-30.

A joint KUIC-BTBC application, entitled "Collaborative Formation and Development of the Bioscience & Technology Business Center at the University of Kansas," was chosen as one of four finalists in the "Community-Connected Campus" category of the UEDA's Awards of Excellence program. At the meeting in Pittsburgh, Julie Goonewardene, associate vice chancellor for innovation and entrepreneurship and president of the KUIC, will be joined on stage by LaVerne Epp, executive chairman of the BTBC. They will make a 15-minute presentation. The audience will then vote for the finalist that best exemplifies the category in the areas of replicability/scalability, sustainability and originality.

[The joint UEDA award application](#) relates the origins of the coalition that made the BTBC a reality, and the close relationship with KU throughout that project. In the process, a culture change occurred at KU in terms of technology commercialization, company formation and licensing, and the articulation of an economic development mission. The application focuses on how the university, KU Endowment, and the community (city, county, and state government) came together as partners to realize the BTBC slogan: "Transforming Ideas into Commerce."



# 2013 State of the State Kansas Economic Policy Conference The Kansas Fiscal Experiment— Impacts on Communities

KU’s Institute for Policy & Social Research will present its annual Kansas Economic Policy Conference on Thursday, October 24, from 8 a.m. to 2 p.m. at the Kansas Union. This year’s topic is “The Kansas Fiscal Experiment – Impacts on Communities,” a title that refers to the restructuring of the state’s tax code in 2012.

“Depending on who you ask, you’ll get very different assessments of the Kansas fiscal experiment,” said Donna Ginther, professor of economics and director of the Center for Science, Technology & Economic Policy. “Supporters of the overhaul have called it an ‘adrenaline shot to the heart’ of the state economy, while others have said it will hurt the state’s ability to provide core services, including K-12 education. The goal of this conference is to analyze the state’s fiscal experiment and focus on how it’s affecting Kansas communities.” Keynote speakers include:

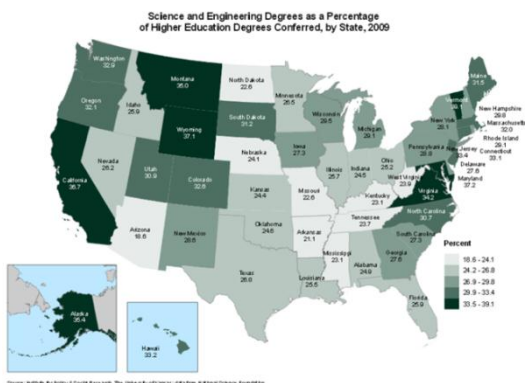

## Kansas Statistical Abstract Provides Wealth of Data in 16 Categories



The Institute for Policy & Social Research has announced that the **47th Edition of the Kansas Statistical Abstract** (KSA) is now available exclusively online as a PDF file, with individual pages available in Microsoft Excel and PDF. The previous 46 editions – dating back to 1965 – are also available at the same site.

The 47th edition contains data collected through July 2013 for 16 categories: Agriculture; Banking and Finance; Business, Industry, and Exports; Climate; Communications and Information; Courts, Crime, and Public Safety; Education; Employment and Earnings; Energy and Natural Resources; Government; Housing and Construction; Income; Parks and Recreation; Population; Transportation; and Vital Statistics and Health.

The 610-page edition contains 259 tables, 79 maps, and 29 graphs with information about Kansas and other states. An example, above, shows science and engineering degrees as a percentage of all higher education degrees conferred in 2009. In Kansas the figure was 24.4%, vs. 28.8% for the U.S. as a whole. Look for the map and table on pages 220-221 (but then expect to spend several more hours checking out the wealth of data available only in the KSA).



## Nancy Biles Named Assistant Director of Pre-Award Services



Nancy Biles, left, interim assistant director in Pre-Award Services since February, has been named to the position on a permanent basis. She reports to Kristi Billinger, assistant vice chancellor and director of research administration, and oversees a staff of pre-award grant officers and specialists at Youngberg Hall.

Biles came to KU in 2000 as a grant specialist. She advanced to grant officer and team leader in 2005. She previously worked for the Howard Hughes Medical Institute in San Francisco, following three years with MSC Working Knowledge, an engineering motion simulation software company in San Mateo. Her academic background includes a B.S. Ed. degree in social sciences from the University of Nebraska at Lincoln.

Pre-Award Services works closely with KU faculty and staff to facilitate the external grant proposal process. The office provides assistance in identifying funding opportunities and preparing, reviewing, approving and submitting competitive proposals for all funding agencies.

## Extension of eRA Commons User IDs to Students with Measurable Role

Over the next year the NIH will start requiring an eRA Commons ID for all individuals in graduate and undergraduate student roles who participate in NIH-funded projects for at least one person-month or more. That information will appear on NIH progress reports, including those submitted on paper using the DHHS Public Health Service Grant Continuation Progress Report (PHS2590, rev. 8/2012), and electronically using the Research Performance Progress Report RPPR, rev. 08/2012.

Pending resolution of the federal government shutdown, beginning on October 18, 2013 a warning will be generated when an RPPR is submitted that lists individuals in a graduate or undergraduate student role who have not established an eRA Commons ID. Then, beginning in October 2014, RPPRs lacking the eRA Commons ID for Graduate and Undergraduate Students will receive an error and the RPPR will not be accepted by the NIH without this information.

## Reminder: October 11 is Deadline for Mandatory Conflict of Interest Reporting

**KU policy** requires that all faculty and unclassified staff must file a conflict of interest (COI) report upon employment, annually, and whenever their circumstances change. Annual COI reporting for fiscal year 2014 began the week of September 16-20, when all faculty and staff affected by the requirement received an email from [ecompliance@ku.edu](mailto:ecompliance@ku.edu) (the online reporting system) containing a link to your certification form. The e-mail subject line was "FY14 Annual Conflict of Interest Certification for [your name]."

### *Call for Applications: Graduate Research Consultant Program*

This spring, the Center for Undergraduate Research will roll out a new program designed to support instructors interested in incorporating research and creative projects into their classes. Based on a highly successful program at the [University of North Carolina](#), the Graduate Research Consultant (GRC) program at KU provides financial support (\$500) to a graduate student or postdoctoral researcher to spend 30 hours over the course of a semester helping to design a research project, mentor students, and evaluate student learning for a particular course. A GRC is not the same as a Graduate Teaching Assistant. The GRC is primarily a research mentor for students in the class and does not grade student work. Instructor/GRC pairs from all disciplines, and for all KU courses, are eligible to apply.
